## Pet Advisor Application-Agreement

Upon acceptance of this application by Petlane, this application becomes a binding legal agreement and I will become an authorized Petlane Independent Pet Advisor.

- 1) I understand and agree that by signature I acknowledge that my sponsor is my official sponsor of record and my Pet Advisor file will always reflect this fact. Petlane will not agree to the transfer of the Independent Pet Advisor to another sponsor and/or Group Leader subsequent to the acceptance of this Application-Agreement by Petlane.
- 2) I understand and agree that I am an independent contractor and not an employee of Petlane for any purpose including, but not limited to, federal state and local taxes. I am responsible for expenses incurred by my business, including sales tax, income tax and self-employment tax. Petlane does not provide me with Worker's Compensation insurance, unemployment compensation or any other employee-type benefit.
- 3) I understand and agree that as an Independent Pet Advisor, I am entitled to all the benefits of the position in accordance with the policies and procedures of Petlane as they are modified and published from time to time in any company authorized publications.
- 4) I understand and agree to purchase the kit of Petlane product and orientation materials in order to become an Independent Pet Advisor. I am not required to maintain inventory. I also understand and agree to purchase a monthly Bottomless Bag subscription of no less than 8lbs of Pure PURR or Pure WOOF beginning 30 days from the date this application is signed and every 30 days thereafter until I notify home office otherwise. Petlane agrees to charge the credit card associated with this application and agreement the total amount of the Bottomless Bag subscription until I make other payment arrangements.
- 5) I understand and agree that a Pet Advisor who fails to meet the stated selling requirements for an active Advisor shall be deemed inactive.
- 6) I understand that I am entitled to cancel participation as a Pet Advisor with Petlane at any time and for any reason upon notice to the company. I understand that sales kit materials must be in resalable condition and in the current line in order to be returned. Anything that is not in resalable condition, as determined solely by PetLane, will be charged back at full retail minus 20%. There will be a 20% stocking fee after 30 days of receipt of sales kit materials, and returns will not be accepted after 120 days.
- 7) I understand and agree that I will apply my best efforts toward the promotion and sales of Petlane products and the Petlane opportunity. I will promote the Petlane name in a manner favorable to me and to Petlane. I understand and agree that I am free to sell Petlane products and sponsor Independent Pet Advisors anywhere in the United States and its territories.
- 8) I understand and agree that I will present Petlane products in accordance with the product descriptions in any company-authorized publications. I will not misrepresent or minimize information on safe and proper use of any and all Petlane products. I will present the Petlane Compensation Plan in accordance with the descriptions and guidelines set forth in any company authorized publications.
- 9) I understand and agree that I will comply with the Petlane policies and procedures as set forth in any company-authorized publications as modified and published from time to time. I will comply with the Petlane trademark, telephone listing and advertising guidelines and use the name, trademarks and logo of Petlane only as specifically authorized.
- 10) I understand and agree that Petlane is committed to the in-home demonstration and related methods of sale as providing the most benefit to pet owners concerned about their pet's health and safety and to Independent Pet Advisors dedicated to establishing successful businesses. Accordingly, I will not sell to or through retail stores or their fixed commercial outlets, or represent in any capacity the products or services of other pet related direct sales companies.
- 11) I understand and agree that I am solely responsible for the maintenance of my account with Petlane and will remit all payments due in a timely fashion. Should my account go to collections, I am solely responsible for any legal fees incurred by Petlane in the collection of my account.
- 12) I understand and agree that Petlane will defend and hold me harmless from any claim of damage or injury from the use of a Petlane product. Petlane will not defend and hold an Independent Petlane Advisor harmless from a claim of damage or injury arising from usage recommended by the Independent Pet Advisor contrary to Petlane's written information for safe and proper use of that Petlane product.
- 13) I understand and agree that Petlane is dedicated to the growth and success of each Independent Pet Advisor's business and will not arbitrarily terminate this Pet Advisor's Application-Agreement. However, Petlane does reserve the right to terminate this Application-Agreement at any time, if I misrepresent Petlane products by making claims contrary to the authorized product literature, or discrediting the Petlane name, or failing to comply with any clause of the Application-Agreement, or failing to comply with any published Petlane policy or procedure, or for any other cause. Only Petlane and I may terminate this Application-Agreement.
- 14) I understand and agree that Independent Pet Advisors shall not sell non-company products to other Pet Advisors or in any way promote to Petlane advisors opportunities in marketing programs of other companies, except with prior written approval from Petlane. In addition, I agree that for a period of one year after termination from Petlane, I shall not directly or indirectly solicit consultants or customers of Petlane or otherwise engage directly or indirectly in raiding activities with respect to advisors and customers of Petlane.
- 15) I understand and agree that the terms and conditions of the Application-Agreement take precedence over any other presentations made to me by other parties.
- 16) I understand and agree that this Application-Agreement shall be governed by the laws of the State of California, any disputes or actions shall be brought in the State of California. Should any provision herein be deemed unenforceable, the remainder of this agreement shall remain in effect. I certify that I am at least 18 years of age and am a permanent resident of the United States or one of its territories.
- 17) I understand and agree that this Application-Agreement shall be void if assigned or transferred by me.
- 18) I understand and agree that I will only use a web site for Petlane business that is authorized by Petlane.
